10:30 – 11:30 a.m. Memory Matters: Linking Alzheimer's Care and Postsurgery Cognitive Issues


Rhea Temmermand, PhD(c), MSN, CRNA is a CRNA and basic science researcher in neuropharmacology in the Department of Pharmacology and Physiology at Drexel University. She studies glutamate transporters on astrocytes and their role in pain modulation, and she is particularly interested in neuropathic pain, non-opioid drug discovery and opioid addiction. In addition to full-time research, Rhea is an Adjunct Professor at Drexel's Nurse Anesthesia program and is co-editor of a comprehensive science textbook for nurse anesthesiologists. Prior to preclinical research, she studied postoperative cognitive dysfunction in vascular patients and published a clinical trial about neurological outcomes after exposure to various anesthetic techniques.

At the conclusion, participants will be able to:

- 1. Analyze the distinctive challenges and considerations associated with administering general anesthesia to individuals with Alzheimer's disease, illustrating a comprehensive understanding of the disease's impact on cognitive function, pharmacodynamics, and perioperative care requirements.
- 2. Evaluate evidence-based preventive measures and procedural modifications that can be employed by nurse anesthesiologists to reduce the risk of postoperative cognitive dysfunction in patients with Alzheimer's disease.
- 3. Formulate a patient-centered approach to Alzheimer's care within the surgical setting that empowers nurse anesthesiologists to optimize the overall perioperative experience and cognitive recovery for this vulnerable population.




